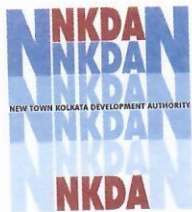

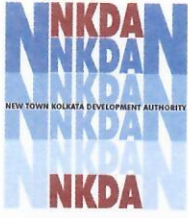

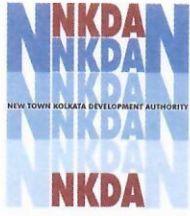

5. SEGREGATION OF SOLID WASTE AT SOURCE (20 Marks)

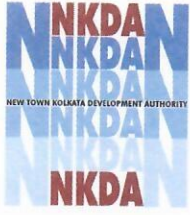

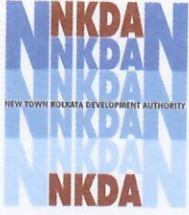
INSTRUCTION FOR PROPOSALS FROM HOUSING BLOCKS & GATED COMMUNITIES

1. There will be separate Ranking for Housing Blocks and Gated Communities. The Rank will be a consolidation of total marks earned across the Nine (9) segments mentioned above.
2. Proposals have to be structured in the manner as indicated above.
3. Each Proposal will include the name of 2 Nodal Officers along with their Designation (in the Resident's Association) and full contact details including phone number and e-mail Ids.
4. The details of the Block Level Association OR Resident Welfare Association will have to be provided including Date of Incorporation and Address.
5. Website/ Facebook/ Twitter/ YouTube (if available) for the Association.
6. General Information of the Residential Block/ Gated Community (as applicable):
 - a. Number of Plots/Dwelling Units
 - b. Population as on 1 October 2020 (estimated based on those residing in New Town)
 - c. Number of Markets, Public Toilets, Street Hawkers, Banks, ATMs, Diagnostic Clinics/ Doctor's Chamber, Medical Shops
 - d. Number of Playgrounds
 - e. Specific Sports/Fitness Activity undertaken for Residents
 - f. Number of Eateries
 - g. Number of General Shops


