

he New Town Kolkata Development Authority has been constituted under The New Town, Kolkata Development Authority Act, 2007 (the West Bengal Act XXX of 2007) for rendering various civic services and amenities within New Town Kolkata and it has become operational since January, 2009.

he Development Authority is cntrusted with some obligatory functions in the sphere of public works and town planning and development. It has regulatory powers to manage planned development and to control unauthorized development.



'he Development Authority has been vested with various powers in respect of control of public streets, parking, parks, gardens; prohibit future construction of building in a particular street; power of inspection of any building at any time requiring sanction; order demolition of buildings deemed as dangerous, unfit for human habitation; Development Authority has the duty to provide water supply and it may impose fee for the use of water. Besides these, it provides and maintains a system of drainage and sewerage, removal and disposal of solid waste.
