2. For keeping Pet Dog at the Pet Creche

(a) For Large Breed:

Rs. 750=00 per day

Rs. 500=00 per day


(c) Security Deposit:

Rs. 10,000=00

- All payments are to be made in advance. Owner of the Pet Dog shall have to submit the Doctors certificate mentioning that the dog does not carry any infectious disease. Copy of document of last vaccination and details of regular medications shall be submitted.
- The owner shall have to deposit the regular medicines for the period of stay in the Dog Creche.
- Only routine emergency medicines will be supplied by the authority. The cost of such treatment will be deducted from the Security Deposit.
- No outside food is allowed. The owner must mention the food habit of the pet dog in the application.
- The Check in / Check out time for the purpose of counting days of stay at Dog Creche will be 12.00 noon.
