- 2. Resident Welfare Associations of AA-1, New Town.


Selection Method:

Selection will be made against valid application form submitted to NTBC. The selection will be made by a committee formed for this purpose. The applicants will be required to present before the selection committee their plan for maintenance and utilization of the playground and financing plan. The selection will be made on the basis of the presentation. Weightage will be given for sports activities in the institution with appropriate sports faculty and achievements in the past. Decision of the selection committee will be final and binding upon all concerned.

- 1. The Selected Institution / RWA will enter into an agreement with NKDA within 15 days of intimation of selection for maintenance and utilization of the ground on payment of Security Deposit on conditional refund.
- 2. The selected Institution / RWA will have to maintain a security deposit of Rs.10,00,000/- (Rupees ten lakh only) inclusive of GST during the tenure of engagement.
- 3. The engagement will be initially for a period of 11 months which may be extended for 2 further terms of 11 months each with a gap of one day, subject to satisfactory performance and on mutual agreement. The first right of refusal will however be reserved by NKDA.
- 4. Selected Institution / RWA would be required to sign an agreement with NKDA on a Rs.50/- Stamp paper (procured by the Agency) before the engagement takes place.
- In case of a loss of property or repair cost required for the ground or any of its associated infrastructure as a result of nonperformance or poor performance by the selected Institution / RWA, the cost will be adjusted from the security deposit under notice to the selected Institution / RWA.
- 6. On cessation of contract period the Security Money balance minus the GST factor will be returned back.
- All sorts of security, maintenance, repair, manpower and electricity will be arranged by selected Institution / RWA including ground, fencing, pathways and lighting fittings and fixtures at their own cost.
- 8. Selected institution will have only operation and access rights without any right and title over the playground.
- 9. The free access to morning and evening walkers shall continue as before.
- 10. No charges will be recovered from the general users by the selected Institution / RWA. Selected Institution / RWA may be allowed to use the ground for play and events of their students and their staff.
- 11. Selected Agencies can organise sports coaching camps for students and children. But for renting out for sports tournaments etc, 50% of the amount will have to be paid to NKDA. Rates should be at par with NKDA Football ground tariff i.e
 - (a) Rs.500/- plus GST for every hour from 9:00AM to 4:00PM
 - (b) Rs.1000/- plus GST for every hour from 4:00PM to 8:00PM
 - (c) Electricity consumption beyond 8:00PM will be @ Rs10.00 per KwH
- 12. If any Institution / Organization other than staff or students of selected Institution / RWA uses the playground, prior permission of NKDA (with a copy to NTBC) shall be obtained by selected Institution and 50% of rent as decided in para 10 above shall be shared with NKDA (NTBC) minimum 24 hrs before the Event
- 13. No change in the infrastructure of the ground shall be made by selected Institution / RWAs without prior written approval of NKDA.
- 14. The access to the playground shall be controlled by selected institution.


