The originals will be contractors from this office on all working days between 11 a.m and 4.00 p.m on production of the aforesaid documents up to the scheduled date.
- 2. The rates are to be quoted both in words and figures as per schedule and perusing necessary Terms & Conditions attached herewith. The rate quoted is valid for acceptance up to 6(six) months from the date of opening of the Tender. The rates quoted should be considered as inclusive of sales tax and other taxes and all other charges. No claim for any extra charge what so ever will be entertained.

3. Eligibility criteria

Intending tenderers should produce credentials of a similar nature of completed work of the minimum value of Rs.1,70,000.00 during 5(five) years prior to the date of issue of the tender notice.

The successful quotationer will have to deposit 2% (Two percent) Earnest Money of quoted price of the total job in the form of Bank Draft/ Banker's Cheque of any Nationalized / Scheduled Bank of India on its Kolkata Branch drawn in favour of New Town Kolkata Development Authority. at the time of making formal agreement.
