## B. General Terms and conditions of Bid

- 1. The empanelled agency will have no objection/claim for any event conducted by NEW TOWN BUSINESS CLUB (NTBC) or any other Govt. agencies of their own.
- 2. The empanelled agency should have prior knowledge about the NTBC and its facilities for parties/programme.
- 3. Green land scaping, pathway, structure and all other facilities available should not be damaged in any form. Penalty will be imposed if such damage or deformation is noticed after the completion of programme.
- 4. The empanelled caterer shall have to pay Guaranteed Plate Money @ Rs.30/- (No. of plates have to be specified beforehand and it may differ by maximum 5%. Anything above the limit of 5% would be charged at Rs.90/-per plate.
- 5. The Caterer selected will also be responsible for distribution of food to the customers through properly levered and trained waiters.
- 6.Cleaning and removing of waste materials including Kitchen waste after completion of the event.
- 7. The empanelled agency should collect all necessary statutory licences if required for the event.
- 8. After submitting EOI, the successful bidder will sign an agreement on a non-judicial stamp paper with the Club authority valid for one year.
- 9. The empanelled agencies will have to abide by all the decisions of the Club Authority, which shall be final.
