Financial bids of those bidders who qualify the technical evaluation will be opened. The evaluation of Bids shall be done based on the Eligibility Criteria and Financial Lowest Cost Basis Selection (LCBS).

Note: -

- a) NKDA would pay the annual rental (inclusive of GST) in equal quarterly installment.
- b) NKDA would pay one-time cost only after successful installation.
- c) NKDA will not bear any other extra cost or recurring other than the annual rental in future.
- d) Rates for any additional /optional features to be mentioned clearly and separately.
- e) The rates quoted should be in Indian rupees only. Price must to be quoted both in figures and in words. In case of a discrepancy in the two, price quoted in words will be taken as valid.
- f) ANY INCREASE IN BANDWIDTH NEEDED WOULD BE ON PRO-RATA BASIS. However, NKDA shall place the order for required additional bandwidth as and when required by giving a written request to the Tenderer.
- g) No other charges would be payable by NKDA.

4. Local Conditions:

It shall be the responsibility on each tenderer to fully inform / acquaint / familiarize itself with local conditions and factors, which may have any effecton the execution of services to be rendered under the contract. All tenderer(s)intending to bid shall visit and make themselves thoroughly acquainted withthe local site conditions.

NKDA shall presume that the tenderer has understood and agreedthat all the relevant factors have been kept in view while submitting the bid. No financial adjustment arising thereof shall be permitted by NKDA, on the basis of any non-clarity of information about local conditions being pleaded by the tenderer. Further, no claim for financial adjustment being made by the contract awarded on these tender documents will be entertained by the NKDA

5. Validity:

Quoted rates must be valid for a period of 180 days from the stipulated last date of submission of bid. The overall offer for the assignment and tenderer(s) quoted price shall remain unchanged during the period of validity. The tenderer(s) should be ready to extend the validity, if required.

6. Installation & Commissioning:

Project will be completed within 3 weeks from the date of issue of the Work order. Fall the aspects of safe delivery, installation, commissioning and uplink of the connectivity shall be the exclusive responsibility of the Service Provider.

If the Service Provider fails to uplink the connectivity by the specified date, then the penalty at the rate of 1% per week of the total order value subject tomaximum of 10% of total order value will be deducted.

7. Payment Terms & Conditions:

Payment will be made quarterly at the end of each quarter for the pro rata annual charges on submission of invoice.

8. Contract Period:

The contract period for providing the Internet Leased Line connectivity to NKDA would be initially for 1 (one) year and may be further extended upon satisfactory Services provided by the Selected Bidder, at the sole discretion of NKDA, based on the requirement of the NKDA on yearly basis, else it will stand cancelled on expiry of contract or on written notice within 30 days.

In the event of the successful bidder failing to execute the work order the next lowest bidder will be awarded the contract.

9. Price Schedule (Commercial Bid)

- a. Bandwidth Charges or Annual Port Charges for 20 MBPS 1:1 uncompressed and unshared Internet Leased Line including last mile on Fiber or WLL.
- b. One-time installation fee (if any)

10. Submission of BID

The bids shall be submitted under Three-Bid System i.e. Technical, EMD & Financial bids addressed to the NKDA. Both the envelopes should be super scribed with Technical Bid and Financial Bid, Tender Title "Tender for 20 MBPS Internet Leased Line (1:1 uncompressed and unshared) for NKDA Office at "NEW TOWN KOLKATA DEVELOPMENT AUTHORITY, ADMINISTRATIVE BUILDING. PLOT NO - DG/13, PREMISES NO - 04-3333, ACTION AREA - ID, NEW TOWN, KOLKATA – 700156". Both the envelopes should be kept in one bigger envelope duly sealed. The Technical bids will be opened first on the prescribed date and time in the presence of representatives of the vendors who wish to be present at time. The Financial Bids of the technically qualified firms will be opened after the evaluation of technical bids. The date and time for opening the Financial Bids will be intimated to the technically qualified firms accordingly. In case, the Tender Opening date is declared a holiday, the tender would be opened on the next working day at prescribed time.

11. Earnest Money Deposit (EMD): Rs. 5,000/- is to be submitted in the form of Demand Draft drawn in favour of "New Town Kolkata Development Authority" Payable at Kolkata. EMD will be converted as a security deposit for successful bidder. For unsuccessful bidder EMD will be refunded on completion of selection of bidder.

12. Award of Contract:

After due evaluation of the financial bid(s), NKDA will award the contract to the technically qualified tenderer (hereinafter referred to as the "Service Provider") having lowest Grand total in Financial Bid (kindly referPart II of para 1 on page 5 of this document)

13. Commencement of Contract:

The Service Provider shall commence the work from the date of receipt ofacceptance of work order Agreement which shall be accepted by the Service Provider not not more than 10 days from the receipt of the work order or 15 days from the date of said order whichever is earlier.

14. Service Provider Obligations:

 The Service Provider shall responsible for providing the 20 MBPS leased line internet connectivity at NKDA Office at "NKDA UNIT OFFICE, ACTION AREA-III, NEWTOWN, WEST BENGAL 700135", at all the time throughout the contract period.

- 2. The Service Provider shall be responsible for supply, installation, configuring and commissioning of hardware at NKDA office and uplink of connectivity.
- 3. Liaising (if required) with other firm(s) for obtaining point to point connectivity between ISP node and NKDA, shall be the responsibility of the Service Provider (necessary hardware should be provided by ISP for point to point link activation if required).
- 4. The Service Provider would insure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks. Service
 Provider shall be responsible for making all the payments towards the local loop charges / rentals / WPC charges etc.
- 5. The Service Provider will do preventive maintenance once a quarter for upkeep of the systems running. The schedule will have to be adhered to strictly by him.
- 6. Should provide performance monitoring system which include real time bandwidth utilization report and site health report.

15. Service Level Guarantee:

- A. The Service Provider shall provide the 20 MBPS (1:1) Internet leased line connectivity at all the time (24X7X365) at NKDA Office at "NKDA UNIT OFFICE, ACTION AREA-III, NEWTOWN, WEST BENGAL 700135".
- **B.** To provide Internet Router Port at ISP Gateway for required Bandwidth and minimum subnet of 8 Public IP addresses including Reverse Lookups configured at these IP's.
- C. Packet Losses: Less than 1 % (Average over 1000 ping) at any given point of time to any part of Country / ISP Internet gateway.
- D. Latency: Less than 100ms from NKDA to ISP's tier 1 peering point. Latency will be randomly checked on daily basis. In case of non- adherence latency limit, the link will be considered as down with effect from time of detection till the time is restored.
- E. Network Availability (uptime): More than 99.50 % per month.

- F. Reports for performance, monitoring / usage like MRTG or equivalent to be submitted by the ISP on monthly basis or as per requirement of NKDA.
- G. Downtime Calculation: Downtime shall be calculated as (Total Time Down Time) X 100 /Total Time. Deduction in payment will be made for downtime in the quarterly bills raised by the ISP.
- H. The response time for attending the faults will be 1 hour after they are reported to the ISP. The ISP will rectify the faults within 12 hours failingwhich; the vendor will arrange temporary replacements. The services shallbe provided 24 X 7 days in a week.
- I. Downtime penalty in % of quarterly payment:
- J. Mean Time to Repair (MTTR), Packet loss and Link failover will be calculated from Network Management System (NMS) provided by the vendor installed at NKDA side or through ISP portal.

16. Jurisdiction:

The courts at Kolkata alone will have the jurisdiction to try any matter, dispute or reference between parties arising out of this tender / contract. It is specifically agreed that no court outside and other than Calcutta High Courtshall have jurisdiction in the matter.

17. Response to the queries received, if any, from bidder or any related Corrigendum, extension of date(s) and others in respect of above tender shallbe issued only on NKDA website www.nkdamar.org. No separate notification shall be issued in the press. Therefore, bidders are requested to regularly visit our website to keep themselves updated.

18. Clarification:

The prospective tenderer(s) requiring any clarification regarding the tender durantare requested to contact "www.nkdamar.org"

- 19. Quotation should be submitted in sealed cover and superscribed with the Name of the Work quotation for, with N.I.Q No.
- 20. The bidder must sign each page of the quotation paper, notice, relevant drawings, schedules etc. which forms part and parcel of the tender document. The intending bidder is required to sign in English or Bengali or Hindi. Signature of bidder in all locations must be identical but the rates shall be quoted in English only.
- 21. The Earnest Money already deposited will be converted as initial Security Deposit. The Security Deposit will be refunded after defect liability period of 01(one) month from the date of completion of the contract.
- 22. The bidder are bound by the terms and conditions of W.B.F No.2911(i)/(ii) along with the specification, notice for calling NIT, Terms & Conditions, if any, and schedule of works etc. which forms part and parcel of the contract deeds.
- 23. Conditional quotation will not be entertained and shall be deemed as 'informal'.
- 24. Before submission of any Bid, bidder may visit the sites and satisfy themselves about the local conditions and also other matters that may be raised in relation to the work. Any bidder who shall submit quotation should be presumed to have done so as no claim whatsoever will be entertained on any account afterwards.
- 25. Taxes as admissible will be deducted as per Govt. orders issued from time to time and would be applicable on the date of making payment of the bills. The rate quoted would remain same throughout the period of contract and should be inclusive of all taxes which are and will also be applicable during the entire tenure of the contract.
- **26.** The successful bidder on receipt of letter of acceptance from the Quotation Accepting Authority, New Town Kolkata Development Authority will have to execute a formal agreement.
- 27. The Tender Inviting Authority reserves the right to deny or accept or reject any or all the applications and even to annul the quotationing process at any point of time without prejudice to further action and without assigning reason thereof.
- **28.** Letter or other instrument submitted separately in modification of the sealed quotation will not be entertained.
- 29. Canvassing in any form is strictly prohibited and any quotationer found to have resorted to canvassing shall be liable to have his Quotation rejected summarily.
- 30. Intending quotationer should note that he will have to work simultaneously with other contractors already entrusted with other work or with contractors to be entrusted with other work in future in the same site. The contractor will have to work in close co-operation and harmony with all the contractors engaged in the project. Any claim for idle labour, for any reason whatsoever, will not be entertained under any circumstances.

- 31. Departmental materials will not be issued under any circumstances. Department, unless otherwise stated means New Town Kolkata Development Authority.
- 32. NKDA will not be held responsible for making payment against any anticipated profit and/or compensation for any losses or price escalation whatsoever for the works as stated in the annexure of this NIT.
