# Notice Inviting Applications for Licensing Shop Spaces on Rental Basis at Different Community Markets in Action Area-I, New Town Kolkata

New Town Kolkata Development Authority (NKDA) invites online offers in one part method (Technical only) from eligible, reputed and resourceful agencies/individuals for operating shops of permitted categories at 8 (eight) different shop spaces on rental basis at 2 different locations in New Town Kolkata under the jurisdiction of NKDA

Interested participants who meet the eligibility criteria may submit a technical bid by e-mail to <a href="mailto:supervisor2@nkda.in">supervisor2@nkda.in</a> .with subject line "Applications for Licensing Shop Spaces at Different Community Markets in Action Area-I, New Town Kolkata" with all the necessary documents as mentioned in this Notice.

Technical proposals submitted by the intending agencies will be evaluated as per norms laid down in this regard. If there are more than one application for a particular shop space, the selection will be made on the basis of interview by a Selection Committee constituted for this purpose. NKDA reserves the right to accept/ reject any or all the offers at its sole discretion without assigning any reason whatsoever and the same will be binding on the applicants.

#### 1. The Offer

New Town Kolkata Development Authority (NKDA) invites offers from eligible, reputed and resourceful agencies in one part system (only technical) for operating shops on rental basis.

#### 2. Terms and Conditions

- a) Any Indian individual who has completed 18 years of age as on the date of Advt, partnership firm (registered/unregistered), trust, HUF, co-operative society, company registered under Indian Companies Act or any other legal entity or authority may apply for allotment.
- b) An applicant/Joint applicant may submit applications for more than one stall/shop but for each stall/shop separate application is required. However, allotment for only one stall/shop will be made to that applicant/joint applicant as per his/her option within the period specified by NKDA. On receipt of option within the specified period, offer of allotment will be made to the applicant/joint applicant for the stall/shop opted by him/her. If, no option is exercised by the applicant/joint applicant within the specified period, NKDA will be at the liberty to allot stall/shop at its discretion.
- c) Indian individual/ partnership firm, trust, HUF, co-operative society, company registered under Indian Companies Act or any other legal entity or authority already in possession of another shop/stall/kiosk under NKDA will not be eligible for participating in this allotment.
- d) Final Scrutiny of the application will be made after application. If the application of any applicant, is found to be incomplete, incorrect or the applicant is found to be ineligible on any account, then that application will be summarily rejected. No offer of allotment will be issue in favour of the applicant in that case.
- e) The Indenture of License of conveyance for the stalls/shops will be drafted by NKDA. It will be shared along with offer letter.
- f) The licensee has to pay stamp duty or other charges, as applicable.
- g) The concerned Co operative Society or Association, after proper intimation to NKDA in writing, shall have to undertake the regular maintenance work and to take up repair jobs as and when required within the market complex to keep market in good condition. But, no structural Change/ modification inside or outside are permitted without prior approval.
- h) NKDA shall not pay the maintenance charge for any vacant stall/shop after the common areas and facilities/ amenities are handed over to the Co-operative /Association formed by the allotees.
- i) All fees, taxes and charges levied by NKDA in respect of individuals stalls/shops or the market complex as whole, shall be payable by the allotees with effect from the date of leave and license offer letter.

- j) The allotees shall have to abide by the rules and regulations of NKDA under jurisdiction the stalls/shops are located or any other such body that may come into existence in future.
- k) Individuals allotees shall have to apply WBSEDCL (West Bengal State Electricity Distribution Company Limited) to obtain electricity connection at his/her/its own stall/shop (leave and license basis) and shall have to pay electricity charges.
- I) All stalls/shops shall have to segregate garbage into bio- degradable and non-bio-degradable category and keep such garbage in separate bins located within the market complex and not to the market premises or within the stalls/shops. No waste material /garbage should be allowed to decomposed or disposed inside the market complex. No littering will be allowed under any circumstances; else, penalty will be imposed upon the concerned allottee for such deviation.
- m) The stalls /shops spaces will be allotted by NKDA on Leave and license basis for a period of 11 months and renewable thereafter.
- n) Allottees of stalls /shops will have to obtain Trade License from NKDA from time to time as per rules on payment of usual License fees.
- o) The allotee will not permit to do any non-structural changes/aesthetical changes within stalls/shops allotted to him/her/its without obtaining permission from NKDA.
- p) The allotees are not permitted to keep any belongings in common areas or pathway or obstruct the common areas.
- q) Allotees are not permitted to keep any inflammable or dangerous items inside the allotted stalls/shops.
- r) NKDA reserve the right to accept or reject any application without assigning any reason whatever. In case of cancellation, no liability will be incurred by NKDA.
- s) Sub-letting of the shop/stall will not be allowed.
- t) The terms and conditions should be read carefully before filling up the application.

#### 4. License Fee

The license fee will be paid in advance on 11 months basis @ Rs.39.6/- per square feet per month plus G.S.T. as applicable.

#### 5. Application money (Non-refundable)

All applicants have to deposit Rs.1000/- (Rupees one thousand) as application money in favour of New Town Kolkata Development Authority (Bank Name: Canara Bank, Account No: 95253070004652, IFSC: CNRB0019525) via online/offline mode for each shop. A copy of the same has to be mailed (<a href="mailto:supervisor2@nkda.in">supervisor2@nkda.in</a>) to NKDA with other documents and the original has to be deposited to NKDA when asked for.

#### 6. Evaluation Procedure

Upon receipt of application from various applicants, NKDA will verify all the credentials submitted by them. Selection of the applications will be done on the basis of eligibility as determined through the submitted documents.

In case multiple applicants chose the same shop/stall for allotment, the selection will be made through interview by a committee constituted for this purpose. One applicant may be the selected allottee for multiple shops. The decision of NKDA will be final and binding in this regard.
