The applicants should also make their own independent investigation in relation to any additional information that may be required. This is not an arrangement and is not an offer or invitation to enter into an agreement of any kind with any party and the information provided at this stage is merely indicative. The Responsive Applicant(s) shall abide by the Rules & Regulations of New Town Kolkata Development Authority



#### **SCOPE OF WORK & CONDITIONS:**

- 1. The concerned Trainers / Agencies will have to make arrangements as per request of the Members of NTBC / residents of New Town to train skating. It would be ensured by the Authority that each trainer gets equal share of classes in a week (combining day and evening classes)
- 2. For unallotted classes, other skaters are permitted to come and utilize the Skating Rink on payment of requisite fee as laid down by the Authority. Only empanelled coaches are permitted to enter the Skating Rink / Premises
- 3. Business Club members / their wards are allowed to practice with or without the presence of trainers free of charge without causing disturbance to the others trainees. In case of disturbance the ward of the Member


- 4. New Town Kolkata Development Authority will under no circumstances be held responsible and will bear no financial liabilities
- 5. The Trainers / Agencies will have to adhere strictly to the rules and regulations of the New Town Kolkata Development Authority in all regards
- 6. The Authority reserves the right to terminate any or all agreements at any point of time without assigning any reason thereof. The contract may be rescinded at any point of time due to bad conduct / work which will be evaluated by the Authority
- 7. Each page of the requisite documents must be stamped and signed by the person or authorized persons submitting the bid in token of his / their having acquainted himself / themselves and accepted the entire bid documents including various conditions. - 8. Qualification criteria of Trainer:
  - a) At least 3 years' experience as a Skating Trainer
  - b) As given in Annexure I
- 9. The revenue collected each month by way of training fees of students will be shared between NTBC and the selected Trainers / Agencies in the ratio of 51%:49% respectively after deduction of GST @ 18%. The payment to the Trainer / Agency will be made after completion of each month within 10 (ten) working days of the following month by way of a crossed cheque drawn in favour of the Trainer / Agency or by online transfer
- 10. All students will pay the fees due to them by card / online transfer / UPI to New Town Business Club by the 5<sup>th</sup> of each month, students failing to pay would be debarred from training for that month. The same student may however join the class next month after paying the requisite fees to NTBC
- 11. After having been selected as successful Trainers / Agencies on written intimation, they shall have to enter into an Agreement with GM, NTBC in duplicate on non-judicial stamp paper of Rs 10.00 (Rupees Ten), the cost of which would be borne by the Trainer / Agency. The Trainer / Agency shall be bound by the terms and conditions of contract to be executed along the specifications as enumerated. The Agreement / Deed of Contract shall be valid for a period of 11 (eleven) months from the date of signing the same. The Agreement can be renewed afterwards on mutual consent
- 13. The Bidder shall not be permitted to withdraw or modify the terms and conditions thereof

14. If the Authority is not satisfied by performance of the manpower, then replacement manpower to be provided within 07 (seven) days, failure of which will lead to termination of the Contract by the Authority


