2. ELIGIBILITY CRITERIA:-

- The Bidder must experience for providing NAS backup solution in any Govt./ Govt. undertaking department least for the last 3 years.
- Turnover of bidder in last 3 years should be minimum 50 Lakhs or above in aggregate and 20 Lakhs or above in last financial year.
- The bidder should have the office in Kolkata having support staff for backup solution.
- Bidder should have the Authorization certificate from OEM related to the proposed NAS solution.

3. GENERAL TERMS AND CONDITION:

- a. The interested firm/company may submit 3(three) sealed separate envelopes respectively envelopes for "Technical Bid", "Financial Bid" and "EMD" in a big outer sealed cover superscribed " Quotation for NAS solution for New Town Kolkata Development Authority located at 03, MAR, New Town, Kolkata –700 156".
- b. Quotation received after due date/ without separate sealed cover/ without rate quoted both in figure and words in specified proforma will not be accepted.
- c. The bidder will have to submit EMD for Rs. 10,000/- (Rupees Ten thousand only) in the shape of Demand draft with any Nationalized / Scheduled Bank in favour of "New Town Kolkata Development Authority" payable at "Kolkata". For the successful bidder EMD shall be retained with New Town Kolkata Development Authority till the security period is over. For unsuccessful bidder EMD will be refunded after completion of the all process. EMD will not be exempted in any case.

- d. The Security period is 01(one) month from the date of completion of the maintenance period.
- e. Supply & installation to be made within 15 days from the date of issue of work order. The Warranty Period is for 02(Two) year from the date of Go-Live of entire solution.
- f. Security deposit will be forfeited in full or part as may be decided by the Authority in case damage/ losses of data by the Authority due to negligence on the part of Agency.
- g. Rate offered by the bidder should be inclusive of all costs, levies but GST is exempted (As NKDA is local Authority).

h. Payment terms:

- 90 % payment will be made on successful implementation and Go-Live of application with requisite document i.e. delivery Challan, installation certificate, warranty certificate.
- Remaining 10% will be released in four half yearly basis on submission of monthly Preventive maintenance report.

4. Scope of Work:

Currently ArcServ is running in NKDA servers where daily automatic backup taking place. The proposed solution will be as follows:

- a) Dedicated storage i.e. NAS solution to be installed in the Server room of NKDA.
- b) The solution to be mounted in the one of Backup server of NKDA. Where daily backup to be scheduled in the NAS solution.
- c) Technical Specification of NAS solution mentioned in Annexure C.
- d) Raw data which is dumped by the Client at backup server also to be taken placed under the solution.
- e) Network architecture and server details are shown in schematic diagram under Annexure D.
- f) Preventive maintenance:

Monthly preventive maintenance to be made by the selected agency for a period of two (02) years with following

- a. Health check-up to be taken for hardware.
- b. Backup status, add/edit/delete of storage policy.
- c. Monthly growth of data to be shown in the preventive maintenance sheet.
- g) Selected Bidder shall be responsible for installation / demonstration wherever applicable and for after sales service during the warranty and thereafter. Warranty shall include free maintenance of the whole equipment and software including free replacement of parts. The defects, if any, shall be attended to on immediate basis. The comprehensive warranty includes onsite warranty with parts. The defects, if any, during the guarantee/warranty period are to be rectified free of charge by arranging free replacement wherever necessary.

5. Opening of Tender:

Tender shall be opened as per Date and Time Schedule. In case Tender opening date is declared HOLIDAY, Tender shall be received and opened on next working day at the same time specified in the NIT (Notice Inviting Tender).

6. The offer shall remain valid for 180 days from the date of opening of the tender.

7. Security Deposit:

The Earnest Money will be converted as Security Deposit for successful bidder. The Security Deposit will be refunded after successful completion of entire work.
