New Town Kolkata development Authority (NKDA), invites sealed bids from registered Companies/firms having experiences in SMS gateway service for "Annual Maintenance Contract (AMC) for existing SMS portal, Long Code Service with keyword and SMS Gateway service for New Town Kolkata Development Authority".

- a. Annual Maintenance Contract (AMC) of existing web portal for sending SMS request.
- b. Selected Bidder have to provide service of shared Long Code with primary keyword(s) and 6 sub keyword(s).
- c. The Keywords will be configured at Operator end based on NKDA requirement & reference.
- d. Data should be forwarded to the Application server of NKDA.
- e. Citizen will send an SMS for registration.
- f. Functions of existing Web portal:
 - Multiple unique Users to access the portal
 - User Dashboard.
 - Dashboard Option Analytical report
 - · Registration count for the month.
 - · Un-subscription count of the month.
 - Total Active user.
 - SMS sends for the month.
 - Upload Mobile No.
 - User can upload mobile numbers through Excel upload to a group. If the mobile no is
 present in the database, the number will be overwritten.
 - · Group Management-
 - VLC Registered User Group: This group cannot be modified by admin. The subscribed & Un-subscribed user will be managed automatically. The Group will not show in-active users. Admin Can download the mobile nos. in a excel file.
 - Custom Group: This can be managed by the admin. The admin can add/delete/manage the group. Admin Can download the mobile nos. in a excel file.
 - Admin will map the group with user for sending SMS. User can view/select the group as per mapping. Unmapped group will be not visible to user.

 - ✓ The message will be sent through NKDA sender ID.
 - ✓ User needs to send the template to the SMS gateway team for approval. Once the template is available. Admin can choose from the list of Template to send the desired message.
 - ✓ Tentative volume of Message will be 10 L (Approx.).

- g. SMS sending via mobile Authorized number from NKDA or other offices / agencies will send a SMS to the ten-digit number mentioning the group name. Automated system will dispatch the SMS to the citizens group immediately.
- h. All data should be stored at the application server of NKDA. In case non-availability of application server, on that case SMS gateway will automatically select the mobile numbers of that particular group as per the last SMS issued by the gateway.
- i. Development to be done on open source product (preferably). In case of any license product, selected bidder has to provide the license by his own cost.
- NKDA will provide the application platform. NKDA installation and configuration to be done by the selected bidder.
- k. Monthly Backup of data to be made by selected agency.
- 1. Necessary promotion in Social Media (Facebook, Twitter) is required to be made for 01 year regarding Long Code.

3. Instruction to Bidders

- 1. Registered Companies / firms having experience in software development are eligible to submit bid.

- 3. The sealed bidding documents should be dropped in the Tender Box at NKDA office on or before the stipulated date and time. The technical bid and the financial bid must be sealed in separate envelopes super scribing "Technical Bid" and "Financial Bid" and both these two envelopes must be placed in a third envelop super scribing "Annual Maintenance Contract (AMC) for existing SMS portal, Long Code Service with keyword and SMS Gateway service for New Town Kolkata Development Authority". This third envelope should be sealed and delivered to the Administrative Officer-I, New Town Kolkata Development Authority, 03, Major Arterial Road, New Town Kolkata -700156.
- 4. Only enclosed formats as provided in original should be used. All sheets need to be submitted after affixing seal of the Company/firms and signature of the authorized signatory conveying acceptance of all terms and conditions of this tender.
- 5. The bidder shall quote the price of the complete project inclusive of GST.
- 6. The bidder should have registered office in Kolkata.
- 7. No price escalation will be allowed.
- 8. Terms of Delivery: The SMS services shall be enabled within 07 days of acceptance of the Work Order which includes integration with NKDA existing system.

- b) The bidder should have a valid trade license.
- c) The bidder should have register office in Kolkata.
- d) The bidders shall have to submit their audited financial statement / audited annual report.
