The Estate Manager-II, New Town Kolkata Development Authority invites Expression of Interest from Bona fide, Resourceful Organisation/ Agencies / Society / Co-Operative Society running Pet Dog Creche & Clinic and Pet Dog Cemetery of NKDA situated at Action Area- III.

1) Manpower Requirement

- a) One full time Veterinary Doctor having experience in similar type of work.
- b) One Livestock Development Assistant (L.D.A) Paravet
- c) One Supervisor / Office Asst.
- d) 03 no Security Person round the clock in 3 shifts of 08 hours each
- e) 03 (three) Multi Tusk Worker (M.T.W) having expertise in Dog caring one each for 3 shifts of 8 hours round the clock.
- f) 03 (three) Personnel for sweeping, Caring, cleaning, and burial work round the clock one each for 3 shifts of 8 hours.

2) Pet Keeping in the Creche-:

a) Fees to be paid in advance

Fee-: a) Rs 500/- per day for small Breed and (b) Rs 750/- per dayfor Large Breed for the days to be kept in the Creche.

b) Security Deposit. Advance payment of Security deposit is to be made.

For total period of stay Rs 10,000/-(Refundable at the time of release of Dog after adjustment of all expenses.)

3). Conditions for keeping Pet Dog.


The Veterinary Doctor will verify the following before Admission / Registration of dog.

- a). No infected or sick pet dog will be received. Fit certificate from a Registered Veterinary Doctor must be submitted. The fit Certificate must clearly mention that the pet dog is not infected with any skin disease or any other disease.
- b) Copy of document of last Vaccination (Vaccination Card) should be produced.
- c) Copy of prescription for routine medications of the Pet Dog from registered Veterinary Doctor to be submitted along with the required Medicines for total period of stay.
- d) In case of death of the pet dog during stay at creche the Authority will not be responsible. However, in case of death due to illness all records of treatment with report of the Veterinary Doctor will be kept in records.

e) No food will be allowed from the Owner of the Dog from outside.

4) PET CLINIC & PET CEMETERY.

- a) Pet Clinic shall be run at a suitabe time on each day (except Sunday). Fees for visit of each Pet Dog will be Rs 150/-(Rupees one hundred fifty).
- b) Photo copy of Death Certificate issued by a Recognized Veterinary Doctor must be submitted at the time of registration for burial of a Pet dog in the Cemetery. Fees of Rs 2500/- (Two thousand five hundred) will be charged for the purpose. A suitable Application Form will be devised for Pet Dog Creche & Clinic and Pet Dog Cemetery.

5) Stake of NKDA

New Town Kolkata Dev. Authority will provide

- a). Full infrastructural facility including Instruments (as per agreement).
- b). Engagement of one Supervisor / Junior Office Asst.
- c) Engagement of Round the clock Security Personnel.
- d) Payment of Electricity Bills.
- e) Collection of all types of Fees / Charges.

6) Scope of Work of the Agency.

The Agency will provide-:

- a). One Full time Veterinary Doctor having expertise in Dog keeping.
- b) Engagement of one Live Stock Dev. Asst. (Para Vet.).
- c). Three Multi Task Worker having expertise in Dog keeping round the clock (1 for each shift)
- d). Three sweeper-cum-Caring Staff round the clock (1 for each shift.)
- e). All recurring expenditure for Human Resource, Cost of Food including feed, Hygenic Items, Purchase of Medicine & Publicity.
- f) The Agency on their part will place the claim to the Auyhority for incurring expenditure for running Pet Dog Creche & Clinic smoothly and Quote Yearly Bid amount for three years.
- g) Engagement period of the Agency will be for 03 (three) years.

7) ELEGIBILITY FOR PARTICIPATION IN E. O. I

Registered, Bona fide, reliable and resourceful Organization/ Agencies / Society/ Co-operative Society / Person having experience in dealing animals or, similar type of work or, having at least one Veterinary professional in the management or, having similar activity in the objective in MOA / Byelaws may participate in this Expression of Interest (E.O.I)
