At the very onset of the meeting, Sri Pradeep Roy, Chief Engineer, New Town Kolkata Development Authority welcomed all the participants present in the meeting and initiated discussions.

Mr. Shine of ENVAC sought clarification regarding Bid Security, Security Deposit and Special Security Deposit (S.S.D).

Executive Engineer – I, mentioned that the same has been elucidated detailed in Tender Document and NIeT. The details regarding Bid Security, Security Deposit and Special Security Deposit (S.S.D) was again clarified by Executive Engineer – I, along with their mode of release.

Regarding power and water arrangement, it was stated by New Town Kolkata Development Authority that the source will be identified by NKDA but agency has to arrange both power and water from such nearest source on their own. The agency has to bear the cost of power during the construction period.

Electrical wing of New Town Kolkata Development Authority stated that power may be available within 150 metres from the Control Room building and underground cable has to be laid to make the power available in the area of work.

Executive Engineer – I, also clarified that septic tank and soak pit is essential because there is no community sewerage system within Eco-Park.

Regarding certain technical specifications as raised by ENVAC pertaining to centre-to-centre distance of Outdoor Collection Units, Inspection Openings and outdoor valves, specification of air / solid waste separator and acoustic insulation for the Collection Station building etc. Executive Engineer – I stated that necessary addenda / corrigendum will be issued after perusal of the same.

It was also stated by Executive Engineer – I that all taxes will have to be taken into account by the agencies for quoting the rate.

PROTOS, KAM AVIDA ENVIRO ENGINEER PVT. LTD and L & T Limited requested regarding the following :-

1. To issue Letter of Credit for supply of all imported equipments.

Chief Engineer and Executive Engineer – I requested them to submit a request letter for the same so that the same may be sent to competent authority for their valued opinion.

 They also requested that the last date of submission of the bids may be extended upto 1<sup>st</sup> week of October, 2015.

NKDA stated that the matter may be considered.
