Out of 02(two) orders, at least 01(one) should be a Govt./Govt.(undertaking)/Semi Govt./Public Sector under taking clients.
- ii) Regarding annual turnover related to vehicles tracking of Rs.50,00,000/- the Bidders should submit the related work orders and completion certificate, either in Company's letter head, duly certified by CEO/MD or by a Chartered Accountant.
- iii) The Graphical re-presentation of vehicles movements are to be mapped in Google image. The VTS should have to be integrated with 'GIS' application in open PRP mode, for this township.
- iv) The selection will be made through Quality cum Cost based method. Cut off marks for technical bid is 30 out of 55. The bidder(s) will be qualified in technical evaluation will be asked to come up with the presentations.
- v) Bidders should have a registered office at Kolkata. If not, than a self declaration is required to be submitted in Non-Judicial stamp paper stating the bidder will open a setup in Kolkata within 03 months after acceptance of work order. Failure of the same will attract a penalty of 1% per week of the tendered value subjected to maximum of 10%.
- vi) Last date of application will be accepted latest by 28.12.2013 at 2:00 PM and the evolution sheet will be published on 30.12.2013 and other dates will be notified within 31.12.2013
- vii) Total no of VTS devices should be 11(eleven) in place of 9(nine) as stated in the schedule of work. The rate is to be accordingly quoted in the schedule of work.
