3. General Conditions:

- 3.1 The bids received without prescribed performance certificate shall be rejected.
- 3.2 Validity of the contract: The period of contract shall be for a period of 06 (Six) months from the date of issue of the work order.
- 3.3 Conditional Tender will not be entertained and shall be deemed as 'informal'. In case of any conditional bids the Earnest Money will be forfeited.
- 3.4 The quotes rate should be per meal per day which includes supply of plate, manpower and transportation cost for delivery of the meal at the designated location.
- 3.5 The rates should be mentioned in figures as well as words
- 3.6 TDS and any other Government levies applicable shall be deducted from bill amount as per rules and instruction issued from time to time, if applicable.

4. Minimum Eligibility Criteria:

- 4.1 The Bidder shall have an experience of food to the State Govt./Central Govt./ Autonomous or Statutory Body under State/Central Govt.
 - 4.2 The bidder should have a valid Trade Licence.
 - 4.3 Xerox copy of valid GST Registration Certificate.
 - 4.4 PAN/TAN No.

5. Scope of work.

- 5.1. Supply of cooked food (full meal) consisting of Rice, Dal, One Sabji (Seasonal Vegetables) and Egg (One number each) Curry to the beneficiaries initially for 125 people in the designated location which may be increase or decrease. Rice grain will be supplied by the Authority.
- 5.2. Rice plate (other than thermocol) is to be supplied by the agency.
- 5.3. Distribute cooked food (hygienic) from 1:00 PM to 3:00 PM to the beneficiary on collection of coupons which has been given in the morning on the same day.
- 6. The bidder have to submit 03 (Three) sealed separate envelopes respectively, for 'Technical Bid', ';Financial Bid' and EMD in a big outer sealed cover supercribed **Operation**, maintenance and Management of Maa Canteen at IIC Market, New Town.

7. Mode of Selection:

The evaluation of the Technical bids will be carried out in the following manner.

- (iv) Technical Bids will be evaluated of only those bidders who fulfil the eligibility criteria.
- (v) Required document list.
- (vi) Past experiences.

8. BID Prices:

The bidders shall have to quote bid prices on the appropriate format for 'Financial Bid Document' enclosed as part of bidding document.

9. Mode of Payment.

Payment will be released on monthly basis on submission of bill in duplicate along with coupons in each month duly certified by the authorised representative of NKDA.

Tender shall be opened as per date and Time Schedule. In case Tender opening date is declared Holiday, tender shall be received and opened on next working day at the same time specified.

- 11 The offer shall remain valid for 180 days from the date of opening of the tender.
- The Bidder will have to submit a token EMD of Rs 2,000.00 (Rupees Two Thousand) 12. only in the shape of Demand Draft with any Nationalized / Scheduled bank in favour of New Town Kolkata Development Authority" payable at KOLKATA. For the successful bidder remaining amount to complete the EMD @ 2% of the quoted rate has to be submitted at the time of agreement and shall be retained with NKDA till the Security period is over . For an unsuccessful bidder the token EMD will be refunded after completion of the process.
