4. Please read "Operation & Maintenance" as "Operation & comprehensive Maintenance" (Ref: BOQ SL No.2.00)
5. Please read "335Wp Solar photo Voltic modules" as "335Wp or above Solar photo Voltic modules" of Technical Specification SI No.1.
6. Quantity of Solar PV Module must fulfil plant capacity. (Ref Technical Specification SI No.1.)
7. Please read "Make-Goodwe/Growatt/Solis" as "Make-Goodwe/Growatt/Solis/Similar Make that fulfils mentioned specifications" of Technical Specification SI No.4.
8. Quantity of AJB & Inverter will be as per site requirement (Ref SI No 3 & 4 of Technical Specification).
9. MNRE Approval not mandatory & OEM / OES both are allowed. (Ref: SI No 5(I) & 5(II)) (Ref Eligibility criteria for participation in the tender).
10. OEM authorization of Inverter and panel are mandatory during supply.
11. Mode of Payments:
  - i. 90% payment of item no. 1 will be released after Supply, installation, testing & commissioning of the plant.
  - ii. 2% payment of item no. 1 will be released each year during 5 years of maintenance period.
  - iii. 20% payment of item no. 2 will be released each year during maintenance period of 5 years post successful installation.
