## The following issues were raised discussed in the meeting:

- a) The participants were informed that, if desired by New Town Kolkata Development Authority/Expert Committee, they will have to make Power Point Presentations of the architectural drawing and design, on a specified data & time.
- b) During submission all architectural drawing sheets should be of A-I size.
- The total manpower who will use the proposed building will be around five hundred.
- d) The successful architectural firm who will be entrusted to do the job will be responsible to obtain the approved architectural drawings from the department of Fire & Emergency Services. They will also be responsible to obtain the NOC from Airports Authority of India (AAI).

- e) The successful architectural firm shall coordinate with the consultant firm/firms who will undertake structural design, electro-mechanical design including fire/HVAC, services design, landscaping etc. He will maintain close liaison with such consulting firm/firms and shall periodically supervise the entire project during construction. The construction period may be considered as 36 months. The above factors may be taken into consideration before quoting rates in the Financial Bid.
- f) It was once again clarified that, the Technical & Financial Bids will be opened on the same date. Evaluation on Technical Bid will be made on a latter date by an expert committee.
