NOTIFICATION

No. 475-UD/O/M/HID/41-03/2013 (Pt.-02)

WHEREAS it has been made to appear to the Governor that in exercise of the power conferred by sub-section (1) of Section 11 of the West Bengal Town and Country (Planning and Development) Act, 1979 (West Bengal Act XIII of 1979) (hereinafter referred as the said Act), the West Bengal Housing Infrastructure Development Corporation (hereinafter is referred as *WBHIDCO*) has been appointed as the Planning Authority within the meaning of the said Act vide the notification Nos. 1490-H1/HG/NTP/1M-1/98, dated 14.09.1999 and 651-H1/HG/NTP/1M-1/98, dated 22.11.2006, of the Housing Department, Government of West Bengal;

AND WHEREAS it has been further made to appear to the Governor that it is necessary to declare certain other areas adjacent to the existing Planning Area of the WBHIDCO to be the “Planning Area” for the purpose of the said Act;

AND WHEREAS it has been also made to appear to the Governor that it is necessary to include certain such other areas adjacent to the existing Planning Area to the existing planning area of the WBHIDCO already declared by the notification Nos. 1418-H1/HG/NTP/1M-1/98, dated 26.08.1999, 1423/HG/NTP/1M-1/98 dated 27.08.1999, 737-H1/HG/NTP/1M-1/98, dated 26.07.2001, 650-H1/HG/NTP/1M-1/98, dated 22.11.2006, 392-H1/HG/NTP/3C-2/2005, dated 21.07.2008, of the Housing Department, Government of West Bengal;

NOW, THEREFORE, in exercise of the power conferred by sub-section (1), read with sub-section (2), of the section 9 of the said Act, the Governor is pleased:

- (a) To declare, with immediate effect, the area described in the schedule mentioned below to be a “Planning Area” for the purpose of the said Act;
- (b) to include, with immediate effect, such areas as described in the schedule mentioned below to the existing Planning area of the WBHIDCO, in pursuance of the provisions of the sub-section (3) of section 9 of the said
